All nominees to pay \$500 to enter and an additional \$1,000 to start. Gross purse \$75,000 of which \$45,000 to be paid to the winner, \$15,000 to second, \$9,000 to third, \$4,500 to fourth and \$1,500 to fifth. 122 lbs. Non-winners of \$60,000 at one mile or over allowed 3 lbs.; non winners of two races other than claiming at one mile or over, 5 lbs.; a race other than claiming, 7 lbs. A trophy will be presented to the winning owner. (Cloudy 65)

WARNING ZONE four wide into the first turn, chased outside a rival or off the rail, came three deep into the stretch, bid outside foes in midstretch, gained the lead nearing the sixteenth pole and pulled clear under left handed urging. **UNUSUAL SUSPECT** saved ground chasing the pace, moved up inside into the stretch, was in a bit tight a sixteenth out but gamely gained the place. **PRIVATE WIND** lugged out into the first turn, pulled his way along to duel outside a rival then between foes leaving the backstretch, battled alongside a rival on the second turn and into the stretch, put a head in front between foes in the lane, drifted out in midstretch then came in under right handed urging in deep stretch and was edged for second. **MAN TO MAN** pulled early, stalked outside a rival, bid three deep leaving the backstretch and on the second turn and into the stretch, steadied when crowded past the eighth pole and was outfinished. **DEADSHOT KEEN (IRE)** pulled between horses early, chased outside a rival or a bit off the rail, came out some in the stretch and could not offer the necessary late kick. **OPTARI** also pulled between foes early then stalked inside, came out into the stretch, was blocked and boxed in from midstretch to deep stretch and lacked the needed rally. **QUIETLY MINE** had good early speed and dueled inside, fought back in the stretch, steadied sharply when crowded in deep stretch and was outfinished. **VARSITY BLUES (IRE)** unhurried and angled in early, settled inside then a bit off the rail, came out in upper stretch and lacked the necessary response. Following a stewards' inquiry, **PRIVATE WIND** was disqualified and placed seventh for interference in the stretch. A claim of foul by the rider of **MAN TO MAN** against the winner was not allowed by the stewards, who ruled **PRIVATE WIND** was the cause of the trouble to the former.
