RUTHERIENNE reserved between horses, rallied outside PRETORIA LIGHT to be up late while just holding off SWEET RANSOM. The latter, allowed to settle, angled outside the leaders for the drive and rallied to just miss while finishing on even terms with PRETORIA LIGHT. The latter, vied for the lead outside BEAUTIFUL VENUE, drew clear from that rival racing down the backstretch while moving to the hedge, made the pace into the stretch, then responded to pressure and just failed to last while dead heating for the place. BEAUTIFUL VENUE vied for the lead along the hedge, was outmoved by PRETORIA LIGHT on the backstretch, continued to chase the pace into the stretch and was outfinished. MADDY'S HEART rated off the pace, raced three wide around the far turn and finished willingly. SILENCE DOGOOD tracked the pace along hedge, was caught in tight in midstretch while trying to get through inside PRETORIA LIGHT, then weakened. COZZI CAPITAL outrun after being steadied in the early going and again entering the first turn, gained some ground without threatening. STREET SOUNDS steadied along the inside on the first turn after brushing the hedge, continued to save ground into the stretch and lacked a late response. DATTS AWESOME steadied in behind COZZI CAPITAL in the early going and was not a factor. PITAMAKAN chased the pace three wide into the far turn and faltered. MARCHESA well placed early, raced four wide on the far turn and faded.
