MISSION IMPAZIBLE chased the pace three wide into the stretch but couldn't get to the winner while clearly best of the rest. MOE MAN reserved early, closed with a mild response off the rail to be up for the show. HOMEBOYKRIS rated off the pace, angled out for the stretch run but had no late response. ROYAL TRICON unhurried after breaking slowly, raced four wide around the turn and failed to menace. RIVERSRUNRYLEE showed speed along the inside to nearing the stretch, then tired. WILLIAM'S KITTEN off slowly, was outrun. SHRIMP DANCER tracked the pace along the inside to midway of the turn, then faltered. L J'S WAY tracked the pace three wide into the turn and faded.
