By subscription of \$300 each by Saturday, February 28, 2009, which shall accompany the nomination, \$3,000 to pass the entry box and \$3,000 additional to start, with \$300,000 Guaranteed. All fees shall be paid before the start of the race. The owner of the winner to receive \$180,000, \$60,000 to second, \$30,000 to third, \$15,000 to fourth, \$9,000 to fifth and \$6,000 to sixth. Weights: Saturday, March 7, 2009. This race will be limited to 14 Starters, with Also Eligibles. High Weights Preferred with second preference to horses with the highest lifetime earnings. Starters to be named through the entry box by the usual time of closing. Trophy to the winning owner. Nominations closed Saturday, February 28th, 2009 with 16 nominations. (Clear 80)

FINALLYMADEIT vied for the lead outside FORMIDABLE, then drifted out through the stretch and wore that rival down for the place while being outfinished by the winner. FORMIDABLE vied for the lead along the inside, edged away from FINALLYMADEIT in midstretch but couldn't resist the top ones late. BRIBON (FR) rated off the pace, raced three wide into the stretch and had no response when asked. COOL COAL MAN tracked the pace along the rail to nearing the stretch, then tired. HOW'S YOUR HALO tracked the leaders into the stretch and faltered.
