SIMBA'S STORY chased three wide and finished evenly. DECISIVE MOMENT chased inside and weakened. AMANECER DE ORO duled inside and tired. DIXIE SLAM raced off the pace, came wide and lacked a rally. BOLD WARRIOR raced off the pace inside and showed little.
