THE USUAL Q. T. stalked inside, came out on the second turn and three deep into the stretch, bid alongside a rival in midstretch, gained the lead, inched clear under urging and proved best. BATTLE OF HASTINGS (GB) three deep early, chased outside a rival, came out from between horses in midstretch and gained the place. ACCLAMATION stalked off the rail or outside a rival, bid alongside a foe on the backstretch and second turn, put a head in front leaving that turn, fought back inside in the stretch and held third. AL KHALI chased a bit off the rail then inside, came out leaving the second turn and three deep into the stretch and just missed the show. RESCUE SQUAD saved ground chasing the pace, came a bit off the rail on the second turn and into the stretch, split rivals in midstretch and was outfinished. METEORE angled in and settled just off the rail, went outside a rival on the backstretch, came out into the stretch and improved position. TAKE THE POINTS three deep early, chased outside a rival, came out leaving the second turn and four wide into the stretch and lacked the needed rally. BLACK BEAR ISLAND (IRE) stalked the pace inside then between foes into and on the second turn, came out three deep into the stretch and did not rally. STRAIGHT STORY sped to the early lead outside a rival, angled in, kicked clear and set the pace inside, dueled leaving the backstretch and on the second turn and weakened in the stretch. SAL THE BARBER chased outside then alongside a rival, went three deep into and on the second turn and four wide into the stretch and lacked a further response. SIR AL (IRE) wide in the chute, angled in and saved ground off the pace, came out into the stretch and was not a threat. BLAZING SPIRIT unhurried and angled in early, saved ground off the pace, continued inside on the second turn and failed to menace.
