1 1/4 MILES. (Turf) (1.443) STAKES. Purse \$300,000 **HOLLYWOOD DERBY (GRADE I) FOR THREE-YEAR-OLDS**. By subscription of \$300 each, which shall accompany the nomination. Closed Thursday November 13, 2014 with 23 Or by supplementary nomination of \$3,000 before the closing time of entries. \$1,000 to pass the entry box and \$3,500 additional to start, with \$300,000 Guaranteed, of which \$180,000 to first, \$60,000 to second, \$36,000 to third, \$18,000 to fourth and \$6,000 to fifth. Weight 122 lbs. Starters to be named through the entry box by the closing time of entries. This race will not be divided. If the number of entries exceeds fourteen (14), first preference will be given to Gr I or Gr II winners in 2014. Second preference will be given to horses placed (second or third) in a Gr I or Gr II in 2014 or Gr III winners in 2014. Total non-claiming earnings in 2014 will be used in determining the order of preference of horses with equal status. A trophy will be presented to the winning owner. (Clear 70)

CALIFORNIA CHROME sped to the early lead outside a rival then angled in, set the pace inside, relinquished command in the run to the first turn and stalked just off the rail, ranged up again into the second turn, re-bid outside SAWYER'S HILL leaving that turn, regained the advantage into the stretch and drew clear under some urging. LEXIE LOU saved ground chasing the pace, came out into the stretch and continued willingly to the wire. TALCO (FR) settled off the pace inside, saved ground throughout, got through along the rail in midstretch and picked up the show. SAWYER'S HILL sent inside, stalked the winner then came out leaving the chute, took the lead outside that rival in the run to the first turn, angled in and set the pace inside, fought back leaving the second turn, came a bit off the rail nearing midstretch and weakened. CABRAL three deep in the chute, angled in and chased outside a rival or a bit off the rail, split horses leaving the backstretch, came out into the stretch, drifted inward in the drive and also weakened. FLAMBOYANT (FR) between horses early, chased outside a rival, went three deep into and out of the second turn and also weakened.
