AMERICAN LION stalked outside a rival then a bit off the rail on the turn, bid three deep in midstretch, gained the advantage nearing the sixteenth pole, inched away under left handed urging and held. GET MY FIX a bit crowded at the start, chased inside, came out into the stretch and again in midstretch and finished willingly outside the winner. SEATTLE RULER stalked the pace inside or a bit off the rail, came out in the stretch, split horses in deep stretch and also went on willingly to the end. MACIAS sped to the early lead, set the pace a bit off the rail, dueled alongside a rival on the turn, fought back between horses in midstretch and until deep stretch and weakened late. INDIAN FIREWATER close up stalking the pace inside, bid along the rail on the turn and in the stretch, also fought back in midstretch and weakened late. TRIBAL FACE chased outside a rival on the backstretch and turn, came out into the stretch and lacked the needed rally. PICO PICO allowed to settle just off the rail, angled in on the turn, came out into the stretch and did not rally. PURSE LUYA settled outside a rival chasing the pace, went three deep a half mile out, continued alongside a foe on the turn, came out into the stretch and lacked a further response.
