I LOST MY CHOO reserved along the inside into the far turn, swung out for the stretch run, rallied to catch FLIBBERJIBIT nearing the sixteenth pole and edged away. RUSTIC FLAME (IRE) unhurried after breaking slowly, saved ground into the far turn, swung out for the stretch run and rallied to be up for the place. FLIBBERJIBIT stalked the pace three wide, rallied to take over at the top of the stretch and opened a clear lead but couldn't resist the top ones late. SCOLARA well placed while saving ground, was steadied when trapped in behind WILD PROMISES leaving the far turn and again in the stretch, then weakened. TEJIDA rated off the pace, advanced into contention in the stretch but had no further response. DATTTTS OUR GIRL outrun early, angled out for the stretch run and improved her position. SOCIAL QUEEN off slowly, failed to menace. LOVE COVE tracked the pace along the inside into the far turn, then tired. ASHLEY RIVER chased the pace three wide to nearing the stretch, then faltered. WILD PROMISES quickly moved to the fore, set the pace under pressure along the rail to the top of the stretch, then faded. AUDACIOUS CHLOE moved up on the first turn to press the pace outside WILD PROMISES to the top of the stretch, then had nothing left. FANCY FUSAICHI was not a factor.
