6 FURLONGS. (1.073) STAKES. Purse \$125,000 HUDSON S. FOR THREE YEAR OLDS AND UPWARD FOALING IN NEW YORK STATE AND APPROVED BY THE NEW YORK STATE-BRED REGISTRY. No nomination fee. A supplemental nomination fee of \$1,250 may be paid at time of entry. \$600 to pass the entry box and \$650 to start. All starters including supplements are required to pay all fees. The purse to be divided 60% to the winner, 20% to second, 10% to third, 5% to fourth, 3% to fifth and 2% divided equally among remaining finishers. Three year olds, 122 lbs. Older 124 lbs. Non-winners of \$40,000 since June 1, 2009 allowed 3 lbs.; a sweepstake in 2009, 5 lbs.; four races, 7 lbs. (Maiden, claiming and starter races not considered in allowances). A trophy will be presented to the winning owner. Closed Saturday, October 10, 2009 with 25 Nominations. (Cloudy 66)

CITIFEST gained on the turn and finished evenly. MR. WINDJAMMER raced inside to the turn and improved his position. DR. W was outrun for a half and rallied mildly. SMOKIN HERO raced up close along the rail into upper stretch and tired. GOODANDACCEPTABLE was used up dueling for the early lead. BE BULLISH chased four wide to the turn and tired. TOO TOUGH PETE was never a factor. LAW ENFORCEMENT was outrun. LOOKIN AT HER faded after going a half.
