No nomination fee. \$750 to pass the entry box and \$1,000 additional to start. \$125,000 guaranteed of which 60% to the owner of the winner, 20% to second, 10% to third, 5% to fourth, 3% to fifth, 2% to sixth. SUPPLEMENTAL NOMINATIONS AT TIME OF ENTRY WITH A FEE OF \$2,500 TO ENTER AND START. Weights: Friday, June 18. Starters to be named through the entry box by the usual time of closing. Should this race not be divided and the entry number exceeds fourteen (14), high weights will be preferred. Different owners will have equal draw according to weights. The second parts of same owner entries will have no consideration over a single interest. Failure to draw into the race cancels all fees. (Clear 77)

CASH REFUND dueled from the outside for the early led, remained in a battle entering the turn with the winner, remained close entering the drive but was no match late. PEACEFUL REIGN pressed the early pace from the inside, remained close entering the drive but was no match late. HUMBLE DESTIN forced the early pace from between foes but had nothing left for the drive. EZ DREAMER was no real threat. AMERICAN CLASSIC was away in good order but outrun.
