All entrants will be required to pay entry and starting fees. NICOLE H was placed under a firm hold soon after the start, took up position in the two path as the field headed for the turn, bided time from there, with the rider still sitting chilly, turned for home, still under wraps, and caught behind traffic, gained a sliver of maneuverability coming to the three-sixteenths pole, took off with a sudden burst of speed, accelerated by the leader to take charge, departing the eighth pole and drew away under very light hand encouragement. MEESE ROCKS was gently urged to the front, set the fractions towards the inside with the rider applying rating tactics, was powerless to hold off the top one, but continued on with good courage to be second best. PURRFECT BLUFF perched three wide within striking distance under a snug hold, moved up to issue a bid for command once given some rein in the vicinity of the three-sixteenths pole, but lacked the necessary response. BOB'S DYLAN attended the pace from the outside during the initial half and folded. QUIET MOVER saved ground on the turn to no avail.
