IN TUNE set the pace under pressure along the inside, then drew clear through the stretch under a strong hand ride. CAMILLE CLAUDEL pressed the pace outside the winner into the stretch but couldn't stay with that rival while proving second best. ROSALIND was stalking the pace along the inside when steadied leaving the first turn, continued to stalk the pace to nearing the stretch, then couldn't keep pace with the top ones. BIRD MAKER tracked the pace into the far turn and tired. COMME CHEZ SOI rated off the pace after breaking slowly, faltered. CHARLIE A off slowly, raced four wide and faded. NAUGHTY HOLIDAY stalked the pace three wide into the far turn and stopped. LADY PARADIME broke awkwardly, then was outrun while saving ground. MY DEAR REGINA was done early and eased in the stretch run.
