A supplemental nomination fee of \$2,000 in addition to the entry and starting fees will be accepted at any time prior to the close of entries. The purse to be divided 60% to the owner of the winner, 20% to second, 10% to third, 5% to fourth, 3% to fifth and 2% divided equally among the remaining finishers. Three year olds 119 lbs. Older 123. Non-winners of a graded sweepstakes in 2013 allowed 21 bs.; \$60,000; or a sweepstake in 2013, 4 lbs.; Three races 6 lbs. SAGE VALLEY showed good speed, was urged along while just off the pace, chased three wide on the turn, pursued the leading duo in upper stretch, gained the lead passing the furlong marker, inched clear into the final sixteenth and proved best under a left-handed whip. POLITICALLYCORRECT came out a bit at the start then was quickly corrected, drifted out a bit early, settled last but one, was urged along while off the rail on the turn, dropped to the inside at the quarter-pole, gained in upper stretch, moved out approaching the furlong marker, chased the winner in the final furlong and finished willingly for the place. HELLO LOVER broke a bit slow, settled at the rear while on the outside, was urged along while four wide on the turn, gained ground under a drive in upper stretch, loomed a threat into the final furlong but flattened out and settled for the show. SOUPER SPEEDY gathered momentum after the start, moved up on the inside to take the lead, set the pace under pressure, was asked for more outside the quarter-pole, dueled with STRAPPING GROOM in upper stretch, battled until just outside the sixteenth-pole then weakened late. STRAPPING GROOM pressed the pace on the outside, vied three then two wide on the turn, dueled with SOUPER SPEEDY into the final furlong and faltered. LAURIE'S ROCKET pressed the pace on the inside of STRAPPING GROOM, vied between rivals on the turn, dropped back while hard ridden near the five-sixteenths pole, chased into the stretch and tired.
