By subscription of \$150 each which should accompany the nomination; \$750 to pass the entry box and an additional \$750 to start. For horses not originally nominated, a supplemental payment of \$2,250 along with the entry and starting fees may be made at any time prior to the closing of entries. The purse to be divided 60% to the owner of the winner, 20% to second, 10% to third, 5% to fourth, 3% to fifth and 2% divided equally amongst the remaining finishers. Weight 123 lbs. Non-winners of \$120,000 or \$60,000 twice allowed 2 lbs.; of \$60,000 allowed 4 lbs.; of two races other than maiden, claiming, starter or state bred in 2015, 6 lbs.; of such a race in 2015, 8 lbs. CAVORTING came away at the break in good order, departed the backstretch placed in the three path, sat well reserved travelling on the turn, swung about five wide into the stretch and got turned loose, made up a good amount of real estate during the next furlong, continued to whittle away at the deficit, won the abbreviated and belated duel with ENCHANTING LADY to earn the top award. ENCHANTING LADY stumbled as the field was sent on its way, secured a prominent position, kept watch on the pace from the three path on the turn, sat poised as the primary primary as the half was being completed and was set down, grabbed a slim lead with slightly under a sixteenth remaining, was herself overtaken by the top one soon afterwards and had to settle for being second best. SPARK gained command shortly after the start, cut over towards the inside, set the first two splits on a loosely-contested lead, spun into the stretch and was switched over to much stronger handling, had the runner up latch on coming to the end of the furlong grounds, resisted that opponent for another sixteenth before yielding then weakened into the show slot. I'M A LOOKER raced in the two path between rivals for much of the way on the turn, was in hand bidding time from the five-sixteenths marker to the top of the lane, lacked the needed response. COCO'S WILDCAT along the rail, disputed the pace during the initial stages, was put to solid encouragement making its way from the top of the bend to its end, faltered. ENCHANTRESS was hustled along nearly from the get-go, raced three to four wide, the widest of all on the turn, set foot into the lane and had no offering. NOBLE AND A BEAUTY saved ground for a half, was placed three wide at the head of the stretch, trailed.
