1 1/4 MILES. (1.413) (Off The Turf) STAKES. Purse \$150,000 JPMORGAN CHASE JESSAMINE S. FOR FILLIES, TWO YEARS OLD. By subscription of \$100 each, which should accompany the nomination or by Supplementary Nomination of \$7,500 by time of entry (Includes entry and starting fees). \$750 to enter and an additional \$750 to start, with \$150,000 guar anteed, of which \$90,000 to the owner of the winner, \$30,000 to second, \$15,000 to third, \$7,500 to fourth, \$4,500 to fifth and \$3,000 to be divided equally among sixth through last. In the event this race is taken off the turf, due to unsafe racing conditions, the horse that wins the 'off the turf' race will NOT receive an automatic qualifying position to enter the Breeders' Cup Juvenile Fillies Turf. Weight: 123 lbs. Non-winners of a group or graded stakes on the turf allowed 2 lbs.; a sweepstakes at a mile or over, 4 lbs.; two races other than maiden or claiming, 6 lbs. Starters to be named through the entry box by the usual time of closing. A set of four silver julep cups will be presented to the owner of the winner. Closed Wednesday, October 7, 2009 with 30 nominations. In the event that this race is taken off the turf it will be contested at Eight and One Half Furlongs on the main track. (Cloudy 46)

HOUSE OF GRACE settled saving ground, advanced along the inside through the second turn, angled out with a furlong to run and was fully extended to wear down SMART SEATTLE in the final strides. SMART SEATTLE was well placed along the inside, got through leaving the second turn, opened clear entering the stretch, continued on well but was denied in the last jump. HATHEER tracked the pace four wide, ranged into striking distance through the second turn, loomed large entering the stretch but went evenly late. CANADIAN STORM was allowed to settle, closed the gap three wide from between horses and improved her position through the lane. WAYNETTA prompted the pace three wide, but weakened from between horses leaving the second turn and faded. WHYDAH was rank to place and pulled to the fore along the inside, fought restraint throughout, came up empty entering the stretch and dropped out. OSCAR DE LA THORN settled in the second flight, angled in with five-sixteenths to run, finished with a belated gain but was never a factor. POORTOWN PRINCESS was unhurried into stride, came five wide but lacked a response when called upon. AVY BABY chased the pace four wide for a half and stopped.
