Non-winners of a Grade 1 in 2009 allowed 2 lbs.; a Grade 2 over a mile in 2009, 4 lbs.; a Graded Sweepstake at a mile or over, 6 lbs.; \$40,000 at a mile or over or three races, 8 lbs. (Maiden, claiming, starter and restricted allowance race s not considered). Any horse that competes in both the Jim Dandy and the Shadwell Travers will have their subscription fees for the Shadwell Travers waived. A trophy will be presented to the winning owner. KENSEI settled in hand for a half mile, pressed the pace from outside while under a hold to the far turn, surged to the front at the three-eighths pole, shook off WARRIOR'S REWARD leaving the quarter pole, opened a clear advantage in midstretch then edged away under steady urging through the final sixteenth. WARRIOR'S REWARD angled in after sprinting clear on the first turn, set the pace under pressure along the inside for nearly six furlongs, relinquished the lead to the winner on the far turn, battled along the rail into upper stretch then continued on willingly to narrowly hold the place. CHARITABLE MAN was reserved well off the rail for six furlongs, swung four wide at the quarter pole and closed late to gain a share. FLAT BOLD steadied after being pinched back at the start, trailed along the backstretch, swung five wide entering the stretch and closed late in the middle of the track. CONVOCATION was under a firm hold between horses for a good part of the way, checked in traffic on the turn, angled to the rail entering the stretch and lacked a late response. SARATOGA SINNER raced up closed along the rail to the turn and gave way.
