FOR FILLIES TWO YEARS OLD FOaled IN NEW YORK STATE AND APPROVED BY THE NEW YORK STATE-BRED REGISTRY.* No nomination fee. \$1,500 to pass the entry box. A supplemental nomination fee of \$3,000 in addition to the entry fee can be made at any time prior to the closing of entries. All starters including supplemental nominees will receive a \$750 rebate. The purse to be divided 60% to the winner, 20% to second, 10% to third, 5% to fourth, 3% to fifth and 2% divided equally among remaining finishers. 122 lbs. Non-winners of a sweepstake or \$60,000 allowed 2 lbs. a race, 4 lbs.; maidens, 6 lbs. (Maiden and claiming races not considered). A trophy will be presented to the winning owner. MISS NARCISSIST left the gate side by side with the runner up, continued heads apart with that opponent before conceded the front, was rated along the inside showing the way, with COURT DANCER making her presence felt parked off her hind quarters, had the pilot of the nemesis be the first to commit the mount to a drive, yet failed to dent into the margin, was switched over from a light hand ride to a more vigorous one as the final furlong commenced, kicked well clear, then was geared down for the final seventy yards. COURT DANCER raced on nearly even terms with the winner during the very initial stages, was taken hold and successfully eased back, tipped outward and hitched up to the top one once more shortly afterwards, prompted the leader from the outside, got set down turning for home, failed to match the winner's impressive burst of speed falling back rapidly while traversing through the furlong grounds and had to settle for being second best. CANAL SIX was quickly guided over to the rail, saved ground until the quarter pole having been been to solid encouragement a furlong up the road, held on to the show award. STAR GRAZING bumped soundly with CHAMPAGNE RUBY at the start, departed the backstretch from the three path, was under a drive after going halfway around the turn, altered course slightly outward in upper stretch, tired. CHAMPAGNE RUBY made solid contact with STAR GRAZING as the field was sent on its way, loosely drafted behind the runner up for the majority of the way on the turn, was given her cue and angled outward near the three-sixteenths marker, had no rally. DADDY'S LIL SAINT three wide at the three-eighths pole, trailed.
