FREE NOMINATION. \$750 to enter and an additional \$750 to start. Supplementary nominations may be made at time of entry on Tuesday, September 10, 2013 by payment of \$4,500 each (includes all fees). \$150,000 includes \$50,000 from the Kentucky Thoroughbred Development Fund. After payment of 1% to all owners of horses finishing sixth through last, 62% of the remaining purse shall be paid to the owner of the winner, 20% to second, 10% to third, 5% to fourth and 3% to fifth. Weight 122 lbs. Non-winners of a race other than maiden or claiming allowed 2 lbs.; a race other than claiming, 4 lbs. The maximum number of starters will be limited to twelve (12). In the event that more than twelve (12) entries pass the entry box the starters will be determined at that time with preference given to the highest career earnings. Any horse excluded from running because of the aforementioned preference shall be refunded the entry fee and supplementary nomination fee if applicable. Starters and riders must be named through the entry box by the usual time of entry. (Pari-mutuel wagering on historic horse races generated \$120,000 of the total purse). LIEN ON KITTEN was unhurried into stride, responded when roused with three furlongs to run, circled six wide into the stretch, engulfed the leader inside the furlong marker and edged clear. J J JULEP stalked the pace off of the inside, launched a bold bid three wide, kicked clear and kept on but was no match for the winner. PERSONAL DIARY was allowed to settle, came four wide and was along for the show. POCKET GIFT prompted the pace two wide, opened clear on the turn, was collared entering the stretch and gave way readily. SATURDAY STORMS was allowed to settle, angled out entering the stretch and finished with a belated gain. REDHEADED WITCH saved ground to little avail. LA MEJOR FIESTA contended between horses, but faltered entering the stretch and faded. MAYBE LILY failed to respond. BECCAWHIT broke sharp, sprinted down the hill to set the pace, but was headed before going a half and stopped.
