ANGEL TERRACE was back early, swung into the six path in the far turn, made a bid in the stretch, drove past the leader and cleared the field late. I O IRELAND set the pace early, shifted into the three path in the far turn and yielded late in the stretch run. TABREED (GB) was reserved early, shifted into the four path in the far turn with a late gain in the stretch drive. ALWAYS KITTEN was unhurried early, on the inside into the far turn, made a bid in the stretch but flattened out late. TOPIC trailed the field early, swung into the six path in the far turn and improved position. BABY FRESH pressed the pace early, angled off the rail into the far turn and was tired in the stretch. CITY OF TRIX stalked the pace early, steadied into the lane and faded late. HONEY LAKE chased the pace early, fanned into the five path in the far turn and was empty late. AULD ALLIANCE (IRE) was through after three quarters. ANY GIVEN CHANCE made a bid entering the lane but stopped.
