5 FURLONGS. (.56²) STAKES. Purse \$150,000 (Includes \$50,000 BC - Breeders' Cup) KENTUCKY S.(GRADE III) FOR TWO-YEAR-OLDS. By subscription of \$150 each, which should accompany the nomination or by Supplementary Nomination of \$7,500 at time of entry. \$750 to pass the entry box; \$750 additional to start, with \$100,000 added. This race includes an additional \$50,000 in Breeders' Cup Funds for Nominees only. After payment of 1% of the host association's added monies to all owners of horses finishing sixth through last, 62% of the remaining purse shall be paid to the owner of the winner, 20% to second, 10% to third, 5% to fourth and 3% to fifth. Breeders' Cup Fund money also correspondingly divided providing a Breeders' Cup Nominee has finished in an awarded position. Any Breeders' Cup money not awarded reverts back to the Fund. Weight: Colts and geldings, 122 lbs.; Fillies, 119 lbs. Non-winners of a race other than maiden or claiming, 2 lbs.; a race other than claiming, 4 lbs. Starters to be named through the entry box at the usual time of closing. All supplementary nominations are required to pay entry and starting fees if they participate. The winning owner to receive a trophy from Breeders' Cup Limited. Closed Wednesday, April 9, 2008 with 50 nominations. (Clear 75)

RUN AWAY AND HIDE closest to the pace while off the inside, challenged late on the turn, raced MERKEL into defeat in midstretch and drew clear under steady urging. GARDEN DISTRICT in tight early when bumped from both sides, moved up three wide on the turn to a challenging position, could not keep pace into the stretch then lodged a mild bid for the place. DREAM OF KAYLEE bumped in the initial furlong, was outsprinted, raced four wide on the turn and improved his position late while no real threat. MERKEL bumped MINE ALL MINE in the initial furlong forcing that one out a bit, set the pace inside, angled out when displaced with a furlong to go but tired.

ESSENCEOFTHAMOON in tight in the initial furlong, raced five wide into the turn, angled to the inside with three furlongs to go and could not menace. MINE ALL MINE bumped out a bit after the start, raced close up along the inside and gave way.
