FREE FIGHTER settled saving ground, split horses entering the stretch and loomed a danger but lacked the needed late response. CELTIC NEW YEAR disputed the pace off of the inside, but faltered from between horses entering the stretch and gave way. IMPONENTE PURSE (BRZ) pressed the pace three wide for a mile and retreated. GUADALCANAL was unhurried into stride, made a belated gain three wide but failed to threaten.
