**NICKY'S BROWN MISS** never far back, rallied outside into stretch, drew clear. **AUNT SHERRI** raced just off the pace, strong run to the lead, no match. **LATE SPRING** settled in backstretch, rallied in stretch, flattened out. **TO BE DETERMINED** good speed to lead, battled to deep stretch, weakened. **EMMAJESTIC** unhurried to the stretch, passed tired ones in the lane. **ARTISTIC TOUCH** never a real menace. **DARK RAIN** improved position. **SIMPLY CONFECTION** through after half. **BELLA RANGER** tried to stay with the pace for a half, gave way readily. **YARMORKA** through early. **MY LITTLE ANNAS (IRE)** never a factor. **SO CAL** broke well, went bad behind several steps from gate and fell then subsequently vanned off in distress.
