5 FURLONGS. (.562) STAKES. Purse \$100,000 KENTUCKY JUVENILE S. (GRADE III) FOR TWO-YEAR-OLDS. ALL STARTERS MUST BE 24 CALENDAR MONTHS OLD TO START. By subscription of \$100 each, which should accompany the nomination or by Supplementary Nomination of \$5,000 at time of entry. \$500 to pass the entry box; \$500 additional to start, with \$100,000 added. After payment of 1% of the host association's added monies to all owners of horses finishing sixth through last, 62% of the remaining purse shall be paid to the owner of the winner, 20% to second, 10% to third, 5% to fourth and 3% to fifth. Weight: Colts and geldings, 122 lbs.; Fillies, 119 lbs. Non-winners of a race other than maiden or claiming, 2 lbs.; a race other than claiming, 4 lbs. All supplementary nominations are required to pay entry and starting fees if they participate. Trophy to winning owner. Closed Wednesday, April 8, 2009 with 49 nominations. (Showery 68)

AEGEAN tracked her stable mate along the inside, shifted out with three-sixteenths to run, took over in the final sixteenth and edged clear late. JEALOUS AGAIN was away alertly and set the pressured pace off of the inside, was unable to match strides with the winner late but kept on well to maintain the place. MISSION IMPAZIBLE bobbled and was bumped at the start, angled in to save ground, closed the gap leaving the turn, swerved to the outside late and was making up ground. WESTERN SMOKE chased the pace four wide but weakened during the drive and gave way. GATOR PROWL broke a step slow, was hustled along in mid pack four wide, drifted about through the drive and finished evenly. KINSOLVING was forwardly placed between horses to the final furlong and faded. HEAVENVILLE settled in the second flight and failed to respond. KITTY IN THE BAG showed little. SEATTLE COURT raced wide throughout and was always outrun.
