

1 1/4 MILES. (1.471) STAKES. Purse \$1,000,000 *LONGINES KENTUCKY OAKS (GRADE I) FILLIES, THREE YEARS OLD*. By subscription of \$200 each on or before February 22, 2014 or \$1,500 each on or before Wednesday, April 9, 2014. A Supplementary Nomination of \$30,000 each may be made at time of entry. \$5,000 to pass the entry box; \$5,000 additional to start, with \$1,000,000 guaranteed. After payment of 1% to all owners of horses finishing sixth through last, 62% of the remaining purse shall be paid to the owner of the winner, 20% to second, 10% to third, 5% to fourth and 3% to fifth. Weight: 121 lbs. The maximum number of starters for the Longines Kentucky Oaks will be limited to fourteen (14) with up to four (4) horses designated as also-eligible to start. If more than fourteen (14) entries pass the entry box, preference will be given to those horses that have accumulated the most points pursuant to the Road to the Kentucky Oaks Point System. For purposes of this preference, the Road to the Kentucky Oaks Point System shall mean the point values assigned to the first four finishing positions in each race comprising the Road to the Kentucky Oaks as published by Churchill Downs Incorporated. Starters to be named through the entry box, Tuesday, April 29, 2014 at the usual time of closing. Closed February 22, 2014 with 122 nominations. (Clear 55)

UNTAPABLE attended the pace four wide under a snug hold, moved up to engage MY MISS SOPHIA midway through the second turn, took over entering the stretch and widened under steady urging. The latter shadowed the leader two wide, assumed a brief lead with three furlongs to run, was quickly collared nearing the five-sixteenths pole, was unable to match strides with the winner but continued on well to clearly prove second best. UNBRIDLED FOREVER was forwardly placed between horses, moved out four wide entering the stretch, went evenly through the drive but maintained the minor award. ROSALIND settled four wide, commenced a long drive with five furlongs to run, churned on between horses and improved position. THANK YOU MARYLOU was well placed between horses, got through three wide but toiled fruitlessly through the drive. RIA ANTONIA worked her way to the outside from between rivals on the first turn, pulled to contention five wide, loomed a danger with five-sixteenths to run, but came up empty entering the lane and faded. GOT LUCKY hesitated at the start, was unhurried into stride four wide, came five wide into the lane, bumped the tiring KISS MOON inside the eighth pole, recovered quickly and finished with a belated gain between horses. SUGAR SHOCK opened clear to set the pace nestled along the inside, was headed three furlongs out, came up empty entering the stretch and retreated. AURELIA'S BELLE saved ground to no avail. PLEASE EXPLAIN was unhurried into stride toward the inside, tipped out four wide on the second turn but lacked a response when called upon. FASHION PLATE was fractious in the gate, hopped at the start to get away behind her field, tucked in to save ground at once, angled out six wide on the second turn but was never a factor. KISS MOON was restless in the gate, broke awkwardly and brushed the gate at the start, moved up four wide, came up empty after six furlongs, was bumped inside the furlong marker as she dropped out.
