By subscription of \$250 each to accompany the nomination or by supplementary nomination of \$5,000 by time of entry. \$2,500 additional to start, with \$250,000 guaranteed, of which \$150,000 to first, \$50,000 to second, \$30,000 to third, \$15,000 to fourth and \$5,000 to fifth. 123 lbs. Non-winners of \$100,000 twice in 2008 allowed 2 lbs.; \$100,000 once in 2008, 4 lbs.; of \$60,000 in 2008 or \$35,000 since September 25, 6 lbs.; of \$30,000 anytime, 8 lbs. (Maiden and claiming races not considered). Graded or Group winners have preference regardless of weight. Starters to be named through the entry box by the closing time of entries. A trophy will be presented to the owner of the winner. Closed with 18. (Clear 60)

INDIAN BLESSING stalked the pace inside then a bit off the rail, bid outside INDYANNE into and on the turn and into the stretch, took a short lead in upper stretch, inched clear and held under urging. GINGER POP chased between horses or outside a rival, continued between foes on the turn and edged a foe for second. BSHARPSONATA stalked outside then three deep into and on the turn and into the stretch and was edged for the place. FOXY DANSEUR settled off the rail then outside a rival, came three deep into the stretch and was outfinished. NEVER RETREAT stalked a bit off the rail then inside, steadied and went around INDYANNE in midstretch and lacked the needed rally. LAURELDEAN GALE chased inside, came out into the stretch, steadied at the trouble in midstretch and could not offer the necessary response. INDYANNE sped to the early lead, set the pace a bit off the rail then inside, dueled inside the winner into and on the turn and until nearing midstretch, took a bad step, was pulled up and vanned off.
