Final closing on November 6, 2009 at \$500. \$400 to pass the entry box; starters to pay an additional \$400. \$100,000 Guaranteed of which \$60,000 to the winner; \$20,000 to second; \$11,000 to third; \$6,000 to fourth; \$3,000 to fifth. WILDLEE** vied for the lead to the drive, the faltered inside the final furlong. **EVEN STEVEN** saved ground and improved position. **JAYS WILDCAT** vied for the lead, got clear before the drive, was overtaken by **RED RALLY** and then faltered late. **TARGET FLASH** raced wide. **FALSE START** settled off the rail, made a run and then had no final kick. **MOYERS** raced wide. **CAT SHOES** raced inside and faded. **CANT COMPLAIN** forwardly placed for a half, stopped. **BOSSIER CITY** unhurried early, retreated.
