Purse \$600,000 **LOUISIANA DERBY (GRADE II) FOR THREE YEAR OLDS.** (Foals of 2006) Early Bird Nomination Fee of \$500 due by Saturday, November 29, 2008, which includes nominating fee for, Lecomte Stakes and Risen Star Stakes (Early Bird). Final nomination for Louisiana Derby closes Saturday, February 28, 2009, by subscription of \$600 each. \$2,400 to pass the entry box; \$3,000 additional to start. Supplementary nominations of \$15,000 will be accepted at time of entry exclusive of entry and start fees. The guaranteed purse will be divided as follows: 60% to first; 20% to second; 11% to third; 6% to fourth and 3% to fifth. Weight: Colts and Geldings, 122 lbs.; Fillies, 117 lbs. This race will be limited to 14 starters. Preference will be given in the following manner: first preference to graded or group winners in order (I,II,III), then highest career earnings (non-restricted), then total career earnings. Second choice high earners of a same owner entry receive no consideration over a single entry. **THE OWNER OF THE WINNER TO RECEIVE A TRIP TO THE OPHY.** Closed Saturday, February 28, 2009, with 105 nominations. (Showery 70)

FRIESAN FIRE three wide around the first turn while up close, was restrained off PAPA CLEM in the run down the backstretch, bid outside that one when ready approaching the drive, took over and drew out under confident handling. PAPA CLEM moved clear early, set the pace while in hand to the second turn, was collared by FRIESAN FIRE nearing the drive, then while no match for that one, was game for second. TERRAIN in tight early on the first turn, settled to race inside to the second turn, angled out for the drive, then lacked a final kick. GIANT OAK trailed early and to the second turn, circled foes while rallying and passed tired rivals. SOUL WARRIOR inside around the first turn, moved out down the backstretch, came three wide around the second turn, then could make little impact. FLYING PEGASUS eased to the inside going to the first turn, maintained a forward position, moved up around the turn, then had no final kick. UNO MAS raced wide. PATENA unhurried early, raced off the rail down the backstretch, came four wide around the second turn, then gave way in the drive. FREE COUNTRY raced inside to the drive, then was steered wide inside the final furlong.
