**6 FURLONGS. (1.08) STAKES. Purse \$100,000 LOUISIANA CHAMPIONS DAY LADIES SPRINT S. FOR FILLIES AND MARES THREE YEARS OLD AND UPWARD, ACCREDITED LOUISIANA BRED. Early bird nominations closed September 15, 2011 at \$150. Final closing on November 1, 2011 at \$500. \$400 to pass the entry box and \$400 additional to start. \$100,000 Guaranteed of which \$60,000 to the winner, \$20,000 to second, \$11,000 to third, \$6,000 to fourth, \$3,000 to fifth. Weight: Three Year Olds- 122 lbs. Older-124 lbs. Non-winners of a graded sweepstakes in 2011 allowed 2 lbs. Non-winners of \$36,000 twice in 2011 all owed 4 lbs. Non-winners of three races other than maiden, claiming or starter in 2011 allowed 6 lbs. Starters to be named through the entry box by the usual time of closing. This Stake will be limited to 14 starters should race not be split. Preference to horses that have accumulated the highest total earnings in 2011. Different owners have equal draw according to money earned. Second choice high earners of a same owner entry receive no consideration over a single entry. **SPEEDACIOUS** raced just off the pace while on the outside, chased four wide on the turn, drifted out while making a bid in upper stretch, inched clear into the final sixteenth then was held together late. **LITTLE POLKA DOT** was away alertly, set the pace, vied off the rail on the turn, was asked at the top of the stretch, lost the lead entering the final furlong and was outfinished while well clear for the place. **U BELONG TO ME** was ridden along while off the pace, raced off the rail on the turn and earned the show. **CHERRY FOREVER** was ridden along on the outside, raced three wide on the turn, swung five wide at the top of the stretch and missed the show. **SCARLET TRIBUTE** lacked early speed, shifted three wide late on the turn, moved out in upper stretch and failed to threaten. **MS HARD CAT** chased the pace, raced three wide on the turn and tired. **DAPHNE ANGELA** was ridden along while off the pace, dropped to the inside near the half-mile pole, raced inside on the turn, took a bad step passing the five-sixteenths pole and was pulled up then vanned off.
