FISHY ADVICE lacked speed, raced six wide leaving the far turn, closed and was along in time. MY DREAM (BRZ) stalked the pace three wide, gained the lead in upper stretch and gave way grudgingly. DREADNAUGHT, unhurried early, raced very wide on the far turn and flattened out between the top pair. PRIVATE SCANDAL, unhurried early, rallied inside horses. GRAY SUITOR, very wide the far turn, lacked the necessary rally. BASTILLE was no factor. BUCKEYE WONDER, six wide turning for home, failed to rally. LEGAL CONTROL was no factor. KING'S CORONATION gave way. TUNE OF THE SPIRIT set the pace along the rail and gave way in upper stretch.

HISSOUTHERNMAJESTY prompted the pace two wide and fell back. SIR CLASSIC CHRIS dropped back.
