Final closing on November 1, 2013 at \$500. \$400 to pass the entry box and \$400 additional to start. \$100,000 Guaranteed of which \$60,000 to the winner; \$20,000 to second; \$11,000 to third; \$6,000 to fourth; \$3,000 to fifth. Weight: 122 lbs. Maidens allowed 5 lbs. (Winners Preferred) Starters to be named through the entry box by the usual time of closing. Preference to horses that have accumulated the highest total earnings. This Stake will be limited to 14 starters. Failure to draw into the race will cancel all fees. LEXI'S LOVE was well placed just off the pace, bided her time while off the rail on the turn, was kept in behind the leading trio coming to the quarter-pole, was asked at the top of the stretch, dropped in under urging near the furlong marker, steadied shortly thereafter then altered course back to the outside, rallied into the final sixteenth and surged past the runner-up at the wire under strong urging. ALL WOMAN tracked the pace on the outside, chased three to four wide on the turn, made a bid at the quarter-pole, gained the lead under a right-handed whip in upper stretch, switched to a left-handed whip near the sixteenth-pole and was denied at the wire. GLAMORIDE was urged along on the outside, went three wide on the turn, swung five wide into the stretch, rallied on the outside to make a bid at the furlong marker but was outfinished while able to get the show. HATAINSROYALROUJ bumped with a rival at the start, moved up to take the lead, set the pace under some pressure, vied inside on the turn, came under a drive in upper stretch and weakened. AIN'T NO BETTER was urged along at the back, raced inside on the turn, moved out in upper stretch and failed to respond. CAROLINE'S PRANCER bumped with a rival at the start, pressed the pace while drifting well out in the track, vied two to three wide on the turn, dropped back under a drive in upper stretch and faded.
