FAB FLOWERS joined the pace outside a rival soon after the start, forced the issue through the bend, forged clear racing into upper stretch and drew away under firm encouragement. YOU BOUGHT HER tracked the leaders outside a rival in the second flight, shifted out three wide in upper stretch and proved best of the others. SWEET TERI K, bumped at the start, was outpaced along the inside racing into the turn, shifted out four wide splitting foes in upper stretch and made an effort to improve position. VICTORIA SHINES broke readily, disputed the lead along the rail racing into the turn and gave way leaving midstretch when failing to match the winner. FANTASY CODE broke inwards bumping SWEET TERI K, was righted to track off the second flight, shifted widest into the stretch but had no rally. GET ME A COCKTAIL, held up just off the first flight along the inside racing into the turn, offered no closing response.
