1 1/8 MILE. (1:43¹) STAKES. Purse \$250,000 Coolmore Lexington S.FOR THREE YEAR OLDS. By subscription of \$150 each, which should accompany the nomination or by Supplementary Nomination of \$7,500 at time of entry (includes entry and starting fees). \$1,250 to enter and an additional \$1,250 to start, with \$250,000 guaranteed, of which \$150,000 to the owner of the winner, \$50,000 to second, \$25,000 to third, \$12,500 to fourth, \$7,500 to fifth and \$5,000 to be divided equally among sixth through last. Weight: 123 lbs. Non-winners of a Grade I or II stakes at a mile or over allowed 3 lbs.; \$59,500 at a mile or over since November 1, 5 lbs. Certain finishing positions in this race will earn points to qualify for the 2015 Kentucky Derby, pursuant to the official rules for the Kentucky Derby published by Churchill Downs Incorporated. The maximum number of starters for the Coolmore Lexington will be limited to fourteen. In the event that more than fourteen pass the entry box, the fourteen starters will be determined at that time with preference given to graded stakes winners (in order I-II-III), then highest earnings. Starters to be named through the entry box by the usual time of closing. Keeneland will present a trophy cup to the owner of the winner. Closed Wednesday, March 25, 2015 with 59 nominations. (Clear 53)

DIVINING ROD tracked the pace early off the rail, shifted into the four path in the far turn, took over command in the stretch and won going away. DONWORTH stalked the pace early, shifted into the three path in the far turn while making a bid but was no match for the winner in the final stages. FAME AND POWER set the pace early, angled off the rail into the far turn and faltered late in the stretch run. COMFORT was bumped and bothered at the start, shifted into the three path in the far turn with some gain in the stretch drive. HENRY JONES was well placed early, shifted into the four path in the far turn and was empty late in the stretch. TIZNOW R J came in at the start and was done early. QUIMET was bumped and bothered at the start, steadied entering the first turn, steadied and hit the rail entering the backstretch.
