BAMA ROSE set the pace along the inside to nearing the quarter pole, then was no match for the winner while holding the place. BROWN EYED SUE stalked the pace along the inside into the stretch, then couldn't keep pace with the winner while gaining some ground on the runner-up. CARAQUISTA rated off the pace after being steadied when she bumped with MAJESTIC MARQUET in the early going, tired in the drive. STREET MAGIC stalked the pace three wide to nearing the stretch, then faltered. DIAMOND MAKER steadied when she bumped with MAJESTIC MARQUET in the early going and was through after six furlongs. FIP FLAP tracked the pace into the far turn and faded. MAJESTIC MARQUET bumped and steadied from between rivals in the early going, was done after a half mile.
