GATOR BREW stalked the pace into the stretch, then drifted out late brushing with THE ISABELLA ANGEL and rallied to be just up at the wire. THE ISABELLA ANGEL reserved early, rallied three wide around the far turn to reach contention, then brushed with GATOR BREW in deep stretch while closing with that rival to just miss. ROMA'S GAL set the pace along the inside into the stretch but couldn't resist the top two at the wire. AGRADAVEL stalked the pace along the inside, was steadied from inside KRISTY N CHANGE leaving the backstretch, angled four wide to chase the leaders into the stretch but couldn't gain late. LOGAN SQUARE was never a factor. AMERICAN BREW was through after a half mile. SEATTLE ZIP tracked the pace into the far turn, then tired. KRISTY N CHANGE was chasing the pace when his rider's saddle slipped on the first turn, remained in contention to the far turn, then faltered. PRIZE FEVER very rank in the early going, was outrun. The rider of THE ISABELLA ANGEL lodged an objection against the rider of GATOR BREW for alleged interference in deep stretch. The claim of foul was not allowed.
