By subscription of \$100 each which should accompany the nomination. \$450 to pass the entry box, \$450 additional to start, with \$100,000 Guaranteed, of which 60% to the winner, 20% to second, 10% to third, 6% to fourth, 3% to fifth and 1% to sixth. Weights: Three-Year-Olds 120 lbs. Older, 124 lbs. Non-winners of \$60,000 twice in 2014, allowed 2 lbs.; \$60,000 once in 2014, 4 lbs.; \$50,000 once in 2014, 6 lbs. (Maiden and Claiming races not considered in estimating allowance). Field will be limited to 10 starters with highest career earnings on the turf in 2013-2014. Horses may be placed on the also eligible list. Trophy to the owner of the winner. Nominations closed Thursday September 18, 2014 with 32 nominations. (If de-emed inadvisable by management to run this race on the Turf course, it will be run on the main track at Six Furlongs) (Rail at 87 feet). (Clear 81)

DREAMSGONEWILD broke well and was up close early, stalked the pace three deep on the turn, responded to urging in the drive, closed outside BOLD THUNDER and was up approaching the wire. BOLD THUNDER showed speed in the two path down the backstretch, opened a clear lead on the turn, remained in the two path, dug in late but failed to repel the winner. BEN'S CAT stalked the pace, moved up three deep on the turn, eased out to the four path in upper stretch and closed the gap outside the top pair. HEAVEN'S RUNWAY , in the middle of the pack early, raced in the two path on the turn and had a mild rally between horses. GRATEFUL NATION lacked speed, was three deep on the turn, eased out to the four path in upper stretch and passed tired rivals. STORMOFTHECENTURY , three deep turning for home, failed to rally between horses. UNSEEN rushed up along the rail down the backstretch, steadied when rank in close quarters entering the turn, remained inside horses and retreated in the drive. BOLTIN' OUT , steadied in close quarters shortly after the break, eased off the rail entering the stretch, raced between horses and failed to be a factor. A P ELVIS saved ground and was not a factor. CALAMONDIN , wide on the turn, was outrun.
