GRAND CONTENDER went to the front, chose the three path on the first turn, was well rated while setting the pace, controlled the action while in the three path on the far turn, was let out some at the five-sixteenths, responded well when set down in upper stretch and drew off under strong a strong left-handed whip. DONOHARM went four wide on the first turn, settled on the outside, was urged along midway down the backstretch, raced five wide while hard ridden on the far turn, advanced at the quarter-pole, chased into upper stretch and proved no match for the winner while able to get the place. F J UNCLE VIC went four wide on the first turn, tracked the pace on the outside, chased four wide on the far turn and tired while able to hold the show. CALLED TO SERVE raced inside on the first turn, settled off the pace, was ridden along in the two path on the far turn and weakened. HE HAS BLING raced in the two path on the first turn, settled at the rear, was ridden along while three wide on the far turn and lacked the needed response. TEXAS AIR was caught five wide on the first turn, dropped back early on the backstretch, moved in near the seven-sixteenths pole, was ridden along while inside on the far turn and came up empty.
