About 5½ FURLONGS. (Turf) (1.024) STAKES. Purse \$60,000 *MARDI GRAS S. FOR THREE YEAR OLD FILLIES*. No Nomination Fee; \$325 to enter; \$350 additional to start. Supplemental nominations of \$1,000 will be accepted at time of entry which shall include all fees. \$60,000 Guaranteed of which \$60% to the winner, 20% to second, 11 % to third, 6% to fourth, 3% to fifth. Weight: 122 lbs. Non-winners of \$45,000 on the turf in 2008-2009 allowed 2 lbs. Two races other than maiden or claiming on the turf allowed 4 lbs. One such race allowed 6 lbs. Starters to be named through the entry box by the usual time of closing. This Stake will be limited to 12 starters should race not be split. Failure to draw into the race will cancel all fees. THE OWNER OF THE WINNER TO RECEIVE A TROPHY. Closed Saturday, February 7, 2009, with 18 nominati ons. (If deemed inadvisable by management to run this race over the turf course, it will be run on the main track at 5 and 1/2 Furlongs.) (Rail at 20 feet). (Clear 65)
