FOR FILLIES AND MARES FOUR YEARS OLD AND UPWARD.** Free nomination by Saturday, February 4th; \$400 to enter; \$400 additional to start. \$75,000 Guaranteed of which 60% to the winner, 20% to second, 10% to third, 4% to fourth, 2% to fifth and 1% to starters sixth through ninth. **Weights:** Sunday February 12th. Starters to be named through the entry box by the usual time of closing. High weights on the scale will be preferred. Different owners have equal draw according to weights. Failure to draw into the race will cancel all fees. **THE OWNER OF THE WINNER TO RECEIVE A TROPHY.** Closed Saturday, February 4, 2012, with 29 nominations. DAISY DEVINE went three wide on the first turn, tracked the leader on the outside, raced three wide on the far turn, made a bid passing the five-sixteenths pole, came four wide into the stretch, drew clear under a drive and held well under strong urging. CHEROKEE QUEEN raced three then two wide on the first turn, settled off the pace, was urged along while two to three wide on the far turn, came under the whip in upper stretch and finished willingly while second best. ROSE MEDALLION was restless in the gate, settled at the rear of the field, was roused on the far turn, came four wide into the stretch and lacked the needed response while able to secure the show. ALLURING SQUALL set the pace while off the rail, lost the lead outside the quarter-pole and gave way. HOLIDAYSATTHEFARM settled towards the inside, was roused on the far turn and failed to rally. (Rail at 22 Feet)
