By subscription of \$125 each which shall accompany the nomination and an additional \$1,250 when making entry. The purse to be divided: 60% to the winner, 20% to second, 10% to third, 5% to fourth, 2% to fifth, 1% to sixth, 1% to seventh, 1% to eighth. Weight: 124 lbs. Non-winners of a Sweepstakes of \$60,000 three times at a mile or over, allowed 3 lbs.; Of a Sweepstakes of \$60,000 twice at a mile or over, 5 lbs.; Of a Sweepstakes of \$60,000 once at a mile or over, 7 lbs.; Of a Sweepstakes of \$60,000 at any distance, 9 lbs. ASSERTING BEAR forced the pace well in hand, chased three-wide into the stretch, was determined and just got up. CONQUEST TOP GUN set a pressured pace, shook clear briefly in the stretch but gave way grudgingly in the final yards. AMI'S HOLIDAY settle off the pace, closed two-wide on the far turn, came off the rail in the stretch looking for room, lost her path and moved back to the rail and finished gamely. TOWER OF TEXAS settled off the pace, was hustled late turn and was all out through the stretch. PUNTROOSKIE, in range, closed four-wide late turn and was game to the end. HEART TO HEART stalked from the rail, angled three-wide late turn and chased through the stretch. A STEWARDS' INQUIRY INTO THE STRETCH RUN AND A CLAIM OF FOUL BY THE RIDER ON AMI'S HOLIDAY AGAINST ASSERTING BEAR FOR INTERFERENCE IN THE STRETCH RESULTED IN ASSERTING BEAR BEING DISQUALIFIED AND PLACED THIRD.
