1 1/4 MILES. (Turf) (1.38) STAKES. Purse \$100,000 *MARSHUA'S RIVER S. (GRADE III) FOR FILLIES AND MARES, FOUR YEAR OLDS AND UPWARD.* (\$15,000 bonus for FTBOA Registered Florida-Bred by an FTBOA Registered Florida Sire). \$1,000 to pass the entry box and \$500 additional to start, with \$100,000 Guaranteed. All fees shall be paid prior to the start of the race. The owner of the winner to receive \$60,000, \$20,000 to second, \$15,000 to third, \$5,000 to fourth, \$3,000 to fifth and \$2,000 to sixth. Supplemental Nominations may be made at the time of entry at a fee of \$5000, which includes entry and starting fees. Weight: 123 lbs. Non-winners of a grade I or II stakes at a mile or over on the turf since August 1, allowed 2 lbs.; graded stakes at a mile or over in 2013 4 lbs., \$45,000 at a mile or over since August 1, 6 lbs. Starters to be named through the entry box by the usual time of closing. Closed Saturday, December, 21, 2013 with 32 Nominations. 1 Supplemental Nomination. Trophy to the winning owner. (If deemed inadvisable to run this race over the turf course, it will be run on the maint rack at One Mile and One Sixteenth) (Rail at 84 feet). (Showery 73)

NAPLES BAY reserved racing along the inside, eased out in early stretch, rallied and split rivals inside the eighth pole to gain the lead, then was fully extended to prevail. SOMALI LEMONADE stalked the pace three wide, rallied to gain a brief lead in the stretch but couldn't stay with the winner while just saving the place. ANGELICA ZAPATA tracked the pace, angled out for the stretch, made a run to loom a threat in midstretch but couldn't gain late while just missing the place. ABACO unhurried early, swung out for the stretch run and closed with a belated rally. DEANAALLEN'SKITTEN allowed to settle, closed ground late without threatening. SILVERETTE set the pace along the rail to nearing the eighth pole and gave way. FLORAL ROMANCE outrun early, swung wide for the stretch run, then steadied when a rival angled out in the stretch and never threatened. VIVA RAFAELA (BRZ) pressed the pace outside SILVERETTE into the stretch, then tired. ROSE TO GOLD reserved in striking position off the pace, faltered in the drive. POETIC KID was not a factor.
