PRINCE WILL I AM rated off the pace about the three path, edged closer leaving the second turn, started his drive passing the half mile pole, took over approaching the final turn and under steady handling to maintain. FREE FIGHTER rated off the pace in the four path, started a drive nearing the final turn, passed the pacesetter at the quarter pole and finished evenly outside. MEMORIAL MANIAC dropped well back early to settle off the rail, started a drive into the final turn, angled inward at the top of the lane and finished evenly for show nearest the inside. PRESIOUS PASSION rated a clear lead off the rail, was under pressure past the half mile pole, relinquished control nearing the final turn but continued to give chase to the lane before fading. SIMMARD stalked the pace off the rail, was pressured for run leaving the five eighths pole and had little left upon reaching the final turn.
