BUSY PROSPECT sped to the front, set the pace along the rail and was under vigorous whipping through the stretch drive. **MOVE THOSE CHAINS** lacked speed, saved ground and rallied. **BELLE'S BROKER** lacked speed, swung wide in upper stretch and rallied. **TOPPING** stumbled shortly after drifting out leaving the starting gate, chased the pace, swung outside entering the stretch and gave way. **ALLEN'S KAT** bobbed leaving the chute, raced along the rail in the stretch and passed tired horses. **ALDEN'S MALIBU**, pinched back leaving the starting gate, was outrun. **JOHNS RUSH**, two wide, chased the winner and faltered. **J Z'S DOUBLE CROSS** was outrun. **SUMMER CARNIVAL** dropped back leaving the turn and was eased.
