NATURAL SEVEN rated kindly inside mid turn, eased out into the lane, surged between rivals in mid stretch, took command soon after, responded to stout right handed pressure and kicked clear. CITIFEST stalked the pace four wide, advanced five wide into the lane, moved to threaten in mid stretch, drifted in some and finished gamely to save the place. HEROS REWARD , forwardly placed between foes, lacked room in upper stretch, shifted to the rail leaving the eighth pole and rallied. LYCURGUS , under stout rating into the turn, gained three wide into the stretch, angled out five wide in upper stretch, advanced between foes past the eighth pole and finished willingly. SANDBAGIN' LOVER lost ground four and five wide and rallied mildly. DISCO DANDY disputed the pace two and three wide, briefly went clear after three furlongs, held well to mid stretch then weakened. KOSMO'S BUDDY stalked the pace three wide, entered the stretch four wide, steadied when in close near mid stretch then faded. EARLSWOOD PETE lacked speed, raced wide in the drive and failed to menace. CASANOVA JACK broke slowly, saved ground into the stretch, lacked room leaving the eighth pole, eased out then lacked a solid response. LOVE YOU TOO disputed the pace along the rail to mid stretch then steadily gave way. TOMMIE'S STAR stalked the pace off the rail, raced between rivals into the stretch and gave way near the furlong marker.
