1 1/2 MILES. (Turf) (1.46) STAKES. Purse \$100,000 *MARYLAND MILLION LADIES S. FOR FILLIES AND MARES, THREE-YEAR-OLDS AND UPWARD.* Pre-entry Fee of \$250, Entry Fee of \$750 and \$1,000 to start. Weight: 121 lbs., Older 126 lbs. Non-winners of a graded stakes at one mile or over in 2011, allowed 3 lbs; an open stakes at one mile or over in 2011, allowed 5 lbs; any stakes at one mile or over in 2011, 7 lbs. Field shall be limited to fourteen (14) starters with preference to highest career earnings in 2010-2011. Horses may be placed on the Also Eligible list. Pre-entry fee refundable to e xcluded horses. (If deemed inadvisable by management to run this race on the Turf course, it will be run on the main track at One Mile and One Eighth) (Rail at 70 feet). (Cloudy 54)

LOVE'S BLUSH lost ground on both turns, swept command outside BALTIMORE BELLE leaving the turn, drifted very wide in midstretch and increased her advantage while under urging. BALTIMORE BELLE stalked the pace, gained a short, two wide lead between horses near the three eighths pole, ran with the winner to the stretch then was out finished. DREAM LOUISE lacked speed, circled the far turn and failed to sustain her bid. MY SWEET NENANA gained the lead outside horses entering the first turn, opened a clear lead on the backstretch, set the pace near the rail and gave way on the far turn. MUSIC PLEASE had brief speed along the rail, dropped back leaving the backstretch, swung wide entering the stretch and failed to rally. DOPKE GAL, outrun, passed tired rivals. LADY RAVEN lacked speed, advanced outside horses on the far turn and gave way in upper stretch. GRANDILOQUENT dropped back. VERA BELLE was outrun. SIMPLE SONGS saved ground and faltered leaving the far turn.
