INNER TURF FOR THREE YEAR OLDS AND UPWARD FOALING IN NEW YORK STATE AND APPROVED BY THE NEW YORK STATE-BRED REGISTRY.* No nomination fee. A supplemental nomination fee of \$1,500 may be paid at time of entry. \$1,500 to pass the entry box. All starters including supplements are required to pay all fees and will receive a \$1,000 rebate. The purse to be divided 60% to the winner, 20% to second, 10% to third, 5% to fourth, 3% to fifth and 2% divided equally among remaining finishers. Three year olds, 120 lbs. Older, 123 lbs. Turf weights: Non-winners of \$60,000 on the turf in 2009 allowed 2 lbs.; a sweepstake on the turf in 2009, 4 lbs.; three races on the turf, 6 lbs. Dirt weights: Non-winners of a sweepstake on the dirt in 2008-09 allowed 3 lbs.; \$30,000 on the dirt in 2008-09 or four races on the dirt 5 lbs. (Maiden, claiming and starter races not considered in allowances). A trophy will be presented to the winning owner. The New York Racing Association reserves the right to transfer this race to the Main Track. Closed Saturday, October 10, 2009 with 38 original nominations and 1 supplement. (Clear 60)

SOLVENT raced well back along the inside to the turn and rallied belatedly. PENNINGTON set the pace along the rail into midstretch and weakened. MY MAN LARS lodged a four wide move on the turn and flattened out.

HANGINGBYATHREAD swung five wide on the turn and closed late in the middle of the track. NORTH COUNTRY saved ground to the turn and steadily tired thereafter. PIAZZA DI SPAGNA was never a factor. KUTAIS chased between horses for six furlongs and tired. TOBRUK raced wide to the turn and gave way. UNCLE T SEVEN saved ground to no avail. PRINCE DUBAI failed to menace.
