BURN THE MORTGAGE broke in at the start, raced three wide on the first turn, tracked the pace on the outside while well out in the course, was urged along while two to three wide on the far turn, chased the winner under the whip into the final furlong and tired while clear for the show. REAL SOLUTION went five wide early on the first turn then dropped to the three path, settled outside on the backstretch, was ridden along while five then four wide on the far turn, came under a right-handed whip outside the quarter-pole, moved to three wide into the stretch, drifted out when switched to a left-handed whip in the vicinity of the furlong marker, went back to a right-handed whip and failed to respond.

POTOMAC RIVER broke about three to four lengths slow, went four to five wide on the first turn, dropped well behind and showed little then pulled up in distress after the race and was vanned off.
