EVANGELINE'S HOPE raced from off the pace, was hustled along the rail on the turn then rallied willingly inside. **JU JU EYEBALLS** dueled, was hustled on the turn then yielded in the final furlong. **SHI SHI FOO FOO** was hustled from off the pace, chased four and five-wide on the turn but never reached contention. **ABERFOYLE MILL** chased in range, came three and four-wide through the turn then flattened out in the stretch. **RUTHERFORD RD** settled off the pace, was hustled three-wide on the turn then lacked a rally.
