1 MILE. (Turf) (1.313) STAKES. Purse \$200,000 (US \$184,060) *NASSAU S. (GRADE II) FOR FILLIES AND MARES, THREE-YEAR-OLDS AND UPWARD.* By subscription of \$200 each which shall accompany the nomination and an additional \$2,000 when making entry. The purse to be divided: 60% to the winner, 20% to second, 10% to third, 5% to fourth, 2% to fifth, 1% to sixth, 1% to seventh, 1% to eighth. Weight: Three-Year-Olds, 119 lbs.; Older, 125 lbs. Non-winners of a Grade I race at a mile or over in 2013-2014, allowed 3 lbs.; Of a Grade II race at a mile or over in 2013-2014, 5 lbs.; Of a Grade III race at a mile or over in 2013-2014, 7 lbs.; Of a Sweepstakes of \$60,000 once at a mile or over in 2013-2014, 9 lbs. (No Canadian Bred Allowance) (Note: Grades as recognized by the International Cataloguing Standards Committee.) Final entries to be made through the entry box at the closing time then in effect for overnight events. A supplemental nomination may be made no later than the time of final entry, by a non-refundable fee of \$4,000, which includes the entry fee. (closed with 26 Nominations) *Plus up to \$24,300 Ontario Sired/Ontario Bred Breeder Awards. (Clear 23)

SOLID APPEAL settled off the pace, saved ground, angled out late turn, launched an all out charge and got up late. WHY KATHERINE stalked three-wide, chased into the stretch, rallied gamely, bid a furlong out and gained a short lead but was caught in deep stretch. DECEPTIVE VISION dueled and was well in hand on the turn, wore down AVIE'S SENSE a furlong out but gave way grudgingly with a 16th to run. SAVVY HESTER stalked the pace, lost her path and checked when trying to split foes in the stretch then chased to the end. SURTSEY stalked the pace, chased four-wide into the stretch, was game but failed to menace. AVIE'S SENSE dueled two-wide the yielded grudgingly a furlong out. NORTHERN PASSION settled well off the pace, was hustled on the turn but never reached contention. QUEEN'S DAUGHTER (FR) broke in the air, settled off the pace, angled out late turn then finished evenly inside. SISTERLY LOVE showed brief speed then stalked the duel from the rail, was steadied late turn and again upper stretch and lacked a rally.
