drew clear under a drive. BOGUE CHITTO stalked two and three-wide, launched an all out drive in the stretch, bid a furlong out, dueled, but was passed with a sixteenth to run. JUNGLE WAVE raced midpack, angled from three-wide to six-wide through the turn, was under a drive

through the stretch, bid a furlong out but failed to sustain the move in the late stages. LITTLE NICK raced off the pace between rivals, angled from two to five-wide on the turn, angled out further midstretch and finished all out. HEROS REWARD stalked the pace, closed five-wide late turn, bid upper stretch, battled, then gave way grudgingly in the late stages. GRAND ADVENTURE stalked the pace, moved to the rail at the top of the stretch, was blocked, drove to a hole a furlong out then bumped CHAMBERLAIN BRIDGE in deep stretch and evened out.

CHAMBERLAIN BRIDGE forced the pace, bid late turn, dueled to the late stages, was bumped late and evened out. STORM TREASURE, off a step slowly, raced well off the pace, was hustled through the stretch but never reached contention. KARAKORUM ELEKTRA, rated off the pace, came three and four-wide through the turn then lacked a strong late response. LEGAL MOVE raced off the pace, angled from four to seven-wide on the turn, was hustled in the stretch but flattened out in the late stages. SILVER Z showed early speed, set a pressured pace,
